Scientific research about the Women on Web services shows that medical abortion can be safely and effectively provided to women themselves through telemedicine. Surgical intervention rates after the medical abortion provided via telemedicine reflect local medical practices. The risk of surgical intervention and ongoing pregnancy after home medical abortion only tends to increase after 12 weeks of pregnancy. **We continue analyzing this unique database with information about women from around the world seeking safe abortion care since 10 years.**

The research supported the initiation of telemedical abortion services in Australia and the USA.

Abortion without the clinic on offer with revolutionary new US program

A pilot study in New York, Hawaii, Oregon and Washington will allow women to receive abortion-inducing drugs through the mail and be crisscrossed by video.

Abortion pill RU486 to be available to Australian women over the phone

For \$350, women in some states will be able to arrange an abortion over the phone, booking ultrasounds and blood tests and ordering the pill to be delivered.

Requests for Abortion in Latin America Related to Concern about Zika Virus Exposure

On November 17, 2015, the Pan American Health Organization (PAHO) issued an epidemiologic alert regarding Zika virus in Latin America. Several countries subsequently issued health advisories, including cautions about microcephaly, declarations of national emergencies, and unprecedented warnings urging women to avoid pregnancy. Yet in most Latin American countries, abortion is illegal or highly restricted, leaving pregnant women with few options.

Northern Irish woman given suspended sentence over self-induced abortion

Belfast woman will go on trial for helping her daughter to have a medical abortion

A Northern Irish woman who bought pills over the internet to induce an abortion has been given a suspended prison sentence.

The 21 year old pleaded guilty to procuring her own abortion by using a poison, and of supplying a poison with intent to procure a miscarriage, and was given a three month sentence suspended for one year.

Her barrister told Belfast crown court on Monday that if his client had lived anywhere else in the UK, she would "not have found herself before the courts".

The abortion drug Mifegyne

A Belfast woman is to stand trial accused of supplying poison for her daughter to have a miscarriage.

Answer to the question: Did the illegality of your abortion affect your feelings?

It made it very difficult to source information (some organisations in Ireland won't give details of reputable UK clinics) I feel that my country has really let me down, in this case where there are so many complications, but they couldn't provide an abortion.

I was worried the package wouldn't get to me, I was also worried that if I got caught it would be in trouble it made me feel like unless I broke the law I was trapped.

It made me incredibly angry at the laws of my own country. I am ashamed to be from a country with such a backward approach to issues like this.

It made it much more difficult practically. It also added immensely to my paranoia that people would somehow find out I was pregnant and I would be prevented from accessing a safe abortion.

I felt hopeless and alone and that I had to hide what I was about to do. On top of all the difficult feelings in deciding to have an abortion, feeling like a criminal is awful. I was terrified I would get caught.

It really annoys me in this day and age in a civilised modern country that abortion is still illegal. It's my body and my choice, not the church or some outdated law.

Yes it makes things a bit more difficult to get support and advice. It made me scared that I could get caught.

It just made it more stressful.

The illegality showed me that there is something wrong with the legal system.

Customs seized 1,017 abortion pills last year

Ruth Coppinger wants the State to stop confiscating the tablets

ANTI-AUSTERITY ALLIANCE TD Ruth Coppinger has called on customs to stop intercepting the delivery of abortion pills bound for Ireland.




And even women in countries where abortion should be available cannot access abortion services

I've just found out I'm pregnant and I can't keep the baby, can you tell me if I can get the tablets from you please. I am in the UK but it's impossible for me to get to a clinic due to having a disabled daughter who I can't leave and I have no one else at all I can trust. I'm in a complete mess. Chris said I have to leave my daughter at home but I have no one else at all to have her due to her disabilities a nursery can't have her. I'm 1 week late, I'm in good health and have no allergies or medical conditions. Please I'm really desperate for help.

I have visited my GP last week and he referred me to my local NHS service. They can only offer me a medical abortion with three visits to the hospital on separate days. On the second visit I am expected to stay there all day. I work full time and have two young sons so getting all that time off and driving is going to be very difficult probably impossible.

I live in South Yorkshire and have no friends and the relatives I have I cannot see. I was hoping to have a termination in the comfort of my own home without judgmental eyes and without worrying about my husband knowing. I fear what would happen if he did. I have children and my 3rd is 11 months old I considered an abortion when he was conceived and had a terrible pregnancy and still suffering from postnatal depression. I will try to seek help, anonymously if possible I'm in great need of help.

I'm a young student and I want to have an abortion because I don't have the financial resources to bring up a child and I'm already drowning in student loans also I don't feel ready for the responsibility of raising (and I want to finish my studies. I live in the United Kingdom. I know abortion is illegal here, but because I am a student I can't afford the cost of the procedure and the place online for supported abortions is just too long and not guaranteed. I feel absolutely horrible and desperate and womenonweb.org seems to be the only place that could help me now. I can't and I gather up the money for donation of your site. I just need to know if you could help me, please.




The pills were ordered online and delivered to addresses in Northern Ireland
